## 1. INTRODUCTION

Matthew Goniwe School of Leadership and Governance (MGSLG) is a provincial teacher development institute of the Gauteng Department of Education. MGSLG has been in the forefront of promoting the integration of ICTs into public ordinary schools by offering training and support in Digital Literacy, subject specific integration as well as online teaching and learning. MGSLG has capacitated more than 20 000 educators in Gauteng Province in the past seven years focusing on improving teacher foundational knowledge through productivity tools for teacher planning, classroom organization, lesson presentation as well as e-assessment. MGSLG developmental plans include rural and informal settlements in which a special mobile solution is mediated to teachers for use in improving lesson delivery. The institution currently utilizes onsite support and training as a means of providing just in time support and training to educators using a differentiated approach to cater for individual teacher needs. As such the institution utilizes a 10:20:70 framework, where 10% of the training is theoretical, 20% being practical engagement and 70 % is work integrated learning, online and offline. Training is conducted in ICT implementing schools across the province and additional support is provided in District Teacher Development Centres.

## 2. PURPOSE

The purpose statement of the program is to develop an e-educator who can teach and mediate learning through digital learning platforms. This tender seeks to secure the services of providers with competence and experience to assist MGSLG with the provision of onsite support and training to 604 ICT implementing schools in the province. The service providers will be required to capacitate teachers on the application of digital technology over a 36-month period based on the needs of the schools. The number of schools may differ based on the expansion of the ICT project by the department of education.

The appointed providers are expected to provide training and support in 15 Districts within the Gauteng Province targeting the following category of schools, Full ICT schools, Schools of Specialization and Technical High schools, Learners with Special Education Needs (LSEN), Twinning as well as Fee and Non-Fee-Paying ICT implementing schools. The identified service providers will be expected to develop and capacitate at least 6 000 teachers across all the phases of the education system in the identified financial year. In addition, the appointed service providers should demonstrate an ability to provide online facilitation and support and use video conferencing equipment as well as the Project Based Learning as an approach to conduct training. This is a six month contract and will be renewable based on performance and availability of funds.

## 3. OBJECTIVES

The objectives of the program are to:

- 3.1 Provide school-based support in Digital Literacy and training in each ICT implementing schools in a financial year period provided there are available funds.
- 3.2 Provide online professional development to educators (Foundation, Intermediate, Senior Phase and FET)
- 3.3 Provision of subject specific ICT integration training and professional development
- 3.4 Capacity building of newly appointed teachers and newly profiled teachers
- 3.5 Capacity building of teachers in Schools of Specialization and Twinning programme
- 3.6 Capacity building of District and School Based ICT Committees on the institutionalization of ICT
- 3.7 Capacity building of Subject Advisors in ICT integration and support

- 3.8 Provision of support and training in the mediation of the Multicertification Handbook for teachers
- 3.9 Provide training and support in Project-Based learning to educators in the ICT implementing schools.
- 3.10 Assist MGSLG to facilitate the development of Professional Learning Communities of practice amongst teachers.

## **4 SCOPE OF SERVICES**

To provide onsite support and training for ICT implementing schools in Gauteng that are supported by MGSLG under the guidance of the GDE by fulfilling the following responsibilities:

- 4.1 Provide onsite ICT integration support and training to 604 ICT implementing schools and 3000 teachers per financial year which includes 35 Schools of Specialization: 8 pairs of Twinning and 25 Mobile Schools across the Gauteng Province that includes deployment of e-learning specialists to schools for at least once a week in the case where minimal support is required and increased level of support to two or more days a week where it is deemed necessary. (10 notional hours per teachers)
- 4.2 Administer an assessment to determine teacher developmental needs
- 4.3 Provide Digital Literacy and Virtual Education (onsite support and training) to 3 000 teachers in the Senior and FET Phases
- 4.4 Provide refresher training to 300 Grade 10-12 Teachers on the development and adaptation of multimedia content for teaching and learning (18 notional hours)
- 4.5 Provide online professional development to 400 Grade 8 and 12 Educators (10 notional hours)
- 4.6 Provide Digital Literacy training to 3 000 Foundation Phase and Intermediate Educators (10 notional hours)
- 4.7 Support the establishment and functionality of Professional Learning Communities (PLC`s) in schools.
- 4.8 Provide professional development to 150 district officials.
- 4.9 Provide professional development to 150 Subject Advisors
- 4.10 Provide weekly, monthly, and quarterly reports on the implementation of the project.
- 4.11 Provision of close out report at the end of the project.

## **5. METHODOLOGY**

- 5.1. The service provider must provide a detailed methodology explaining the project execution process that will cover all the project scope of work and project milestones.
- 5.2. The methodology must show timeline throughout the project lifecycle.
- 5.3. The bidder must provide and demonstrate a clear understanding of ICT integration for teaching and learning.
- 5.4. Develop a post training and support framework for monitoring the use of ICT`s in schools.

### **5.1 PRE -QUALIFICATION COMPETENCIES & EXPERTISE REQUIREMENTS (Standards must be in line with the Evaluation Criteria)**

- 5.1.1. At least 5 years of relevant experience in Teacher Development or e-Learning professional development teachers.
- 5.1.2. The Qualified bidder should exhibit the first-hand experience of working on training projects in collaboration with the education sector, other organizations and training and development providers.
- 5.1.3. The Qualified bidder should demonstrate how they will incorporate 21<sup>st</sup>-century skills for teachers in their Programmes which include the integration of ICTs in the classroom.
- 5.1.4. The Qualified bidder should have knowledge of project management.
- 5.1.5.** The Qualified bidder should have team members who are qualified with relevant experience on teacher development and training.

## 6. OUTPUTS AND DELIVERABLES

This will be a collaborative venture which will mean that both parties (MGSLG and the service provider) play their roles for the project to succeed. The attainment of outputs and deliverables should be informed by the following documents:

- 6.1 A Detailed Project Plan
- 6.2 Inception report detailing methodology and work plan.
- 6.3 Design and development of the training material for specific teachers` needs
- 6.4 Training materials should be SACE Endorsed
- 6.5 Provision of 80 ICT Trainers/Content integrators and 5 District Coordinators
- 6.6 Detailed training reports (weekly, monthly , Quarterly)
- 6.7 Detailed close out report

## 7. EVALUATION PROCESS

The Evaluation Process comprises the following stages:

### 7.1 Pre-evaluation stage/ mandatory documents

- During this phase, bid documents will be reviewed to determine compliance with tax matters and whether original and valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

Bidders must attach the following mandatory returnable documents to be considered for this bid:

- Original and valid tax clearance or Printed copy tax clearance certificate accompanied by a pin for further verification.
- Certified ID(s) copies of company director(s)
- Certified Proof of company registration
- Proof of registration on National Treasury Central Supplier Database (CSD) not older than one month.
- Company municipal rates, electricity or water account not older than three months, proof of Residential lease or rental or sworn affidavit if the business operates at a place of residence.
- Completed and signed Standard Bidding Document (SDB) attached in the tender document.
- Proof of company banking details e.g. bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.
- Company profile with a minimum of 5 years' experience in working in the relevant field.

***Failure to submit all of the above-mentioned documents will result in the disqualification of the bid.***

The bidder should apply for registration on the MGSLG Supplier Database. Application forms for registration are available on the MGSLG Website [www.mgslg.co.za](http://www.mgslg.co.za) . The duly completed application form should be submitted together with the proposal.

## 7.2 Stage 1: Technical/Functionality Evaluation

- a) Bids will be evaluated strictly according to the bid evaluation criteria stipulated in this section of the Terms of Reference (ToR). During this stage bidders' responses will be evaluated for functionality based on achieving a minimum score of seventy-five percent (75%). Bidders who obtain less than 75% in the functionality points will be regarded as non-responsive and will be eliminated from the evaluation process.
- b) Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated in this document. The panel responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.
- c) Bidders will not rate themselves but need to ensure that all information is supplied as required. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify all documents submitted by the bidders.
- d) The panel members will individually evaluate the responses received against the following criteria as set out below:

- e) Each panel member will rate each individual criterion as per the above point allocation scales:
- f) The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- g) This score will be converted to a percentage and **only** bidders that have met or exceeded the minimum threshold of 75% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.
- h) Any proposal not meeting a minimum score of 75 percent technical proposal will be regarded as non-responsive and it will not be evaluated further.



## 8. STAGE 2: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- a) In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be evaluated by MGSLG on the 80/20 – preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:

- The bid price (maximum 80 points)
- Broad-Based Black Economic Empowerment as well as specific goals

(maximum 20 points)

- b) The following formula will be used to calculate the points for price in respect of bidders with a Rand value below R50 000 000.00:

$$P_s = 80 \left\{ \frac{1 - (P_t - P_{\min})}{P_{\min}} \right\}$$

Where

$P_s$  = Points scored for comparative price of bid under consideration

$P_t$  = Comparative price of bid under consideration, inclusive of VAT

$P_{\min}$  = Comparative price of lowest acceptable bid, inclusive of VAT

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

## 9. B-BBEE POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be below R50 Million in accordance with the formula and applicable points provided for in the respective status level contributor tables in the Regulations.

Failure to capture the required status level and to submit the certified or original B-BBEE status level certificates no points will be allocated to the service providers.

- a. The points scored by a bidder in respect of the points indicated above will be added to the points scored for price.
- b. Bidders are requested to complete the various preference claim forms in order to claim preference points.
- c. Only a bidder who has completed and signed the declaration part of the preference claim form will be considered for B-BBEE Status.
- d. Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to B-BBEE Status.
- e. Points scored will be rounded off to the nearest 2 decimals.
- f. In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for B-BBEE Status. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored a highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots.
- g. A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.
- h. ***MGSLG reserves the right to arrange contracts with more than one contractor.***
- i. ***MGSLG reserves a right to withdraw, cancel or not to award this tender***

## 10. COMMUNICATION

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

## **11. PROHIBITION OF RESTRICTIVE PRACTICES**

- a. In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:
- Directly or indirectly fixing a purchase or selling price or any other trading condition
  - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
  - Collusive bidding.
- b. If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

## **12. FRONTING**

- a. MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognises that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- b. MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine that accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.
- c. The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliant with B-BBEE companies.

### **13. COMPULSORY BRIEFING**

A compulsory briefing session will be held on **23 NOVEMBER 2023 AT 10H00** at the Vrededorp Campus of the Matthew Goniwe School of Leadership and Governance. This session will provide bidders an opportunity to clarify certain aspects of the process as set out in this document and to address any substantial issues they might have.

### **14. PRESENTATION**

MGSLG may require presentation/interviews from shortlisted bidders as part of the bid process.

## 25. DECLARATION CERTIFICATE FOR LOCAL PRODUCTION AND CONTENT FOR DESIGNATED SECTORS
