1. INTRODUCTION

Matthew Goniwe School of Leadership and Governance (MGSLG) is a provincial teacher development, governance and leadership institute of the Gauteng Department of Education (GDE).

An Overview of the organisation:

As a Not-for-Profit Company (NPC) established in 2002, we design, develop, and deliver training programmes and courses to capacitate teachers, learners, and parents. MGSLG delivers targeted, evidence-based interventions that strengthen the education ecosystem.

2. PURPOSE

The Matthew Goniwe School of Leadership and Governance (MGSLG) invites suitably qualified and experienced service providers to submit proposals for the provision of internal audit services. The purpose of this appointment is to establish an independent internal audit function that will assist the organisation in achieving its objectives by evaluating and improving the effectiveness of risk management, control, and governance processes. The duration of the contract is 5 years, renewable annually based on performance.

Our core programmes include:

- Teacher Development: Empowering educators with subject content, pedagogy, and digital literacy.
- Early Childhood Development (ECD): Equipping practitioners with foundational teaching skills and qualifications.
- School Governance: Training School Governing Bodies (SGBs) and Representative Councils of Learners (RCLs) to lead with integrity.
- Education Leadership: Supporting principals and SMTs through mentoring, curriculum management, and agile leadership.
- ICT Integration: Transforming teaching through technology and preparing learners for the Fourth Industrial Revolution.
- Psychosocial Support: Creating safe, inclusive learning environments through partnerships and learner support agents.
- Research and Quality Assurance: Driving excellence through monitoring, evaluation, and impact studies.

3. OBJECTIVE

These services are intended to support the organisation through independent, objective assurance and advisory activities that add value and improve operational effectiveness within the education and training environment. The internal audit function must assist in maintaining efficient and effective controls. Through evaluations the function must make recommendations of improvements and enhancements.

The internal audit function will assist the organisation in achieving its strategic, operational, and compliance objectives by evaluating and improving the effectiveness of governance, risk management, and internal control processes, with specific focus on the following areas:

3.1. Governance and Oversight

- Assess the effectiveness of governance structures, including the Board and Audit Committee,
- Evaluate whether decision-making processes support ethical leadership and accountability in line with the King IV Report on Corporate Governance
- Promote a culture of compliance, transparency, and continuous improvement

3.2. Regulatory and Accreditation Compliance

- Provide assurance on compliance with education and training regulatory bodies such as the Quality Council for Trades and Occupations (QCTO) and relevant Sector Education and Training Authorities (SETAs),
- Assess compliance with applicable legislation and frameworks governing skills development and training providers

3.3. Funding and Grants Management

- Evaluate controls over the management of training grants from Gauteng Department of Education (GDE)
- Review compliance with funding agreements and reporting requirements of Gauteng Department of Education (GDE) and other relevant stakeholders

3.4. Quality of Training Delivery

- Review processes to ensure that training programmes are delivered in accordance with approved curriculum and standards as set by GDE
- Assess monitoring mechanisms for facilitator performance
- Evaluate internal quality assurance processes

3.5. Financial Management and Internal Controls

Evaluate the adequacy and effectiveness of financial controls related to:

- Revenue recognition
- Expenditure management
- Payroll (including facilitators and contractors)
- Assess safeguarding of assets and prevention of fraud

3.6. Supply Chain and Procurement

- Review procurement processes for goods and services, ensuring they are in line with policy
- Assess fairness, transparency, and compliance with internal policies and applicable regulations

3.7. Information Technology and Systems

- Assess data security, system access controls, and cybersecurity risks
- Review system integration with regulatory reporting platforms

3.8. Fraud Prevention and Detection

- Evaluate controls designed to prevent and detect fraud, particularly in
- Training facilitators claims
- Overall financial management
- Procurement processes
- Conduct investigations where required

3.9. Advisory and Continuous Improvement

- Provide advisory services on improving processes, controls, and efficiency
- Support management in strengthening governance and operational effectiveness without compromising independence

4. SCOPE OF SERVICES

The appointed service provider will conduct audits in line with applicable framework and standards, including;

4.1. Planning

- Conduct a risk assessment
- Develop a 5-year rolling internal audit plan
- Prepare annual audit plans

4.2. Execution

- Perform audits in line with the approved plan
- Conduct special investigations where required

4.3. Reporting

- Issue audit reports with findings, risk ratings, and recommendations
- Present reports to management and the Audit Committee

4.4. Follow-Up

- Monitor implementation of agreed corrective actions

4.5. Advisory Services

- Provide independent advisory services

5. METHODOLOGY AND PRE-REQUIREMENTS

5.1 The service provider must:

- Comply with the standards of the Institute of Internal Auditors (IIA)
- Apply a risk-based audit approach
- Align with King V Report on Corporate Governance principles
- Comply with applicable South African legislation

5.2. The bidders must:

- 5.2.1. Have proven experience in the training or education sector
- 5.2.2. Demonstrate knowledge of SETA/QCTO requirements
- 5.2.3. Employ qualified professionals (CIA, CA(SA), CISA, etc.)
- 5.2.4 Have capacity to deliver the required services

6. OUTPUTS AND DELIVERABLES

The service provider must deliver:

- 6.1. Risk-based 5-year internal audit plan
- 6.2. Annual audit plan
- 6.3. Individual audit reports
- 6.4. Quarterly progress reports
- 6.5. Annual internal audit report
- 6.6. Audit Committee presentations

7. EVALUATION PROCESS

The Evaluation Process comprises the following 3 stages;

7.1. STAGE 1 Pre-evaluation stage/ mandatory documents

During this phase bid documents will be reviewed to determine compliance with tax matters and whether valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

Bidders must attach the following mandatory returnable documents in order to be considered for this bid:

1. Valid tax clearance certificate copy accompanied by a pin for further verification,
2. Certified ID(s) copies of company director(s)
3. Certified Proof of company registration
4. Proof of registration on National Treasury Central Supplier Database (CSD) not older than one month from the closing date.
5. Company municipal rates, electricity/water account not older than three months, proof of Residential lease, or sworn affidavit if the business operates at a place of residence.
6. Completed and signed Standard Bidding Document (SDB) attached in the tender document.
7. Proof of company banking details e.g. bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.
8. Confirmation from Institute of Internal Audit (IIA-SA) that proposed team members, who are members, are members in good standing with IIA

Failure to submit all of the above mentioned document may result in the disqualification of the bid.

9. Verification documents for points claimed for specific goals;
 - a. Certified copies of company directors IDs,
 - b. CSD summary report not older than 1 month from the closing date,
 - c. Certified copy of CIPC Company registration document
 - d. Valid BBBEE certificate
 - e. Completed SBD Preference Points claim form

Failure to submit the above will result in points not being awarded for specific goals

7.2. STAGE 2 Technical/Functionality Evaluation

Bids will be evaluated strictly according to the bid evaluation criteria stipulated in this section. During this stage bidders' responses will be evaluated for functionality based on achieving a minimum score of seventy five percent (75%). Bidders who obtain less than 75% in the functionality points will be regarded as non-responsive and will be eliminated from the evaluation process.

Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated in this document. The panel responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.

Bidders will not rate themselves, but need to ensure that all information is supplied as required. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify all documents submitted by the bidders.

The panel members will individually evaluate the responses received against the following criteria as set out below:

7.2.2. Minimum Qualifying Score

Each panel member will rate each individual criterion as per the above point allocation scales.

This score will be converted to a percentage and **only** bidders that have met or exceeded the minimum threshold of 75% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.

Any proposal not meeting a **minimum score of 75%** on the technical proposal will be regarded as non-responsive and it will not be evaluated further.

8. STAGE 3: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), and

regulations issued in 2022, responsive bids will be evaluated by MGSLG on the 80/20 – preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:

- The bid price (maximum 80 points)
- Broad-Based Black Economic Empowerment as well as specific goals (maximum 20 points)

b) The following formula will be used to calculate the points for price in respect of bids with a Rand value below R50 000 000.00:

$$P_s = 80 \left\{ 1 - \frac{(P_t - P_{\min})}{P_{\min}} \right\}$$

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration, inclusive of VAT

$P_{\min}$ = Comparative price of lowest acceptable bid, inclusive of VAT

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

9. PREFERENTIAL POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be below R50 Million in accordance with the formula and applicable points provided for in the respective Regulations.

- a. The points scored by a bidder in respect of the specific goals will be added to the points scored for price.
- b. Bidders are requested to complete the various preference claim forms in order to claim preference

points.

- c. Only a bidder who has completed and signed the preference claim form will be considered.
- d. Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to points claimed.
- e. Points scored will be rounded off to the nearest 2 decimals.
- f. In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for specific goals. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored the highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots..
- g. A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.
- h. ***MGSLG reserves the right to arrange contracts with more than one contractor.***
- i. ***MGSLG reserves a right to withdraw, cancel or not to award this tender.***
- j. The bidder should apply for registration on the MGSLG Supplier Database. Application forms for registration are available on the MGSLG Website www.mgslg.co.za . The duly completed application form should be submitted together with the financial proposal.

10.COMMUNICATION

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

11.PROHIBITION OF RESTRICTIVE PRACTICES

- a. In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:
 - Directly or indirectly fixing a purchase or selling price or any other trading condition
 - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
 - Collusive bidding.
- b. If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

12.FRONTING

- a. MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognises that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- b. MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine that accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.
- c. The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliant with B-BBEE companies.

MGSLG may require presentation/interviews from shortlisted bidders as part of the bid process.

21.TAX CLEARANCE CERTIFICATE REQUIREMENTS

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

1. In order to meet this requirement bidders are required to complete in full the attached form TCC 001 "Application for a Tax Clearance Certificate" and submit it to any SARS branch office nationally. The Tax Clearance Certificate Requirements are also applicable to foreign bidders / individuals who wish to submit bids.
2. SARS will then furnish the bidder with a Tax Clearance Certificate that will be valid for a period of 1 (one) year from the date of approval.
