1. INTRODUCTION

The Matthew Goniwe School of Leadership and Governance (MGSLG) is a Non-Profit Company (NPC) established in 2002 to serve as the capacity-building arm of the Gauteng Department of Education (GDE), responsible for developing and delivering leadership, governance, occupational, and academic programmes that strengthen the capabilities of educators, school leaders, and education stakeholders across Gauteng province.

2. PURPOSE

Purpose of the Terms of Reference

The purpose of these Terms of Reference is, to invite qualified and experienced ICT (Information and Communication Technology) consulting service providers to submit proposals for comprehensive ICT consulting and managed support services, to MGSLG.

The successful service provider will deliver:

- Strategic ICT advisory services;
- ICT infrastructure management;
- Cybersecurity support;
- Cloud services management;
- Digital transformation initiatives;
- ICT governance; and
- Technical support.

These services must ensure that MGSLG's ICT environment remains secure, reliable and efficient, and aligned with the organisation's strategic objectives.

The appointment aims to improve ICT service delivery, operational efficiency, strengthen ICT governance and compliance, reduce technology-related risks, and support the implementation of innovative digital solutions.

3. OBJECTIVES

The primary objective of an ICT consulting firm is to help organizations use technology effectively to achieve their business goals. Key objectives include:

4.11 Provision for MGSLG Training Institute requirements

As MGSLG operates as a training institute and capacity-building entity, the appointed ICT consulting service provider must ensure that all ICT recommendations, systems, support arrangements, and digital transformation initiatives are aligned to the delivery of training, professional development, and learning support services. This includes;

- i. Assessing and supporting the effective use, integration, security, and sustainability of learning management systems, virtual learning platforms, online assessment tools, webinar platforms, digital content repositories, and learner support technologies.
- ii. Advise on ICT solutions that strengthen blended learning, online facilitation, digital pedagogy, communities of practice, teacher development programmes, and large-scale training delivery across schools, districts, and provincial stakeholders.
- iii. Ensuring that learner, educator, facilitator, and participant data is securely managed in line with applicable data protection, privacy, records-management, and information-security requirements.
- iv. Developing practical standards for digital training environments, including user access, authentication, device readiness, bandwidth requirements, technical support, platform

- availability, accessibility, and business continuity during training delivery.
- v. Supporting the development of dashboards and reports that enable MGSLG to track training participation, attendance, completion, certification, learner feedback, programme performance, and ICT service levels.
 - vi. Providing advice on assistive technologies, inclusive digital access, and reasonable accommodation measures to ensure that digital training services are accessible to participants with diverse learning needs.
 - vii. Implementing structured knowledge transfer to MGSLG staff, facilitators, administrators, and ICT personnel so that internal teams can manage systems, support users, interpret reports, and sustain digital training operations beyond the contract period.
 - viii. Reviewing and advising on the MGSLG website, online registration tools, communication platforms, and digital service channels to ensure they support programme marketing, learner enrolment, information sharing, stakeholder communication, and institutional credibility.

5. METHODOLOGY

The methodology must demonstrate a clear understanding of the scope of work and set out how all project requirements and deliverables will be achieved. This should include a structured implementation plan outlining key activities, timelines, milestones, and deliverables.

7. EVALUATION PROCESS

The Evaluation Process comprises the following stages:

7.1 Pre-evaluation stage/ mandatory documents

During this phase bid documents will be reviewed to determine compliance with tax matters and whether valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

1. Valid tax clearance certificate copy accompanied by a pin for further verification,
2. Certified ID(s) copies of company director(s)
3. Certified Proof of company registration
4. Proof of registration on National Treasury Central Supplier Database (CSD) not older than one month.
5. Company municipal rates, electricity/water account not older than three months, proof of Residential lease, or sworn affidavit if the business operates at a place of residence.
6. Completed and signed Standard Bidding Document (SDB) attached in the tender document.
7. Proof of company banking details e.g. bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.
8. Confirmation from Institute of Internal Audit (IIA-SA) that proposed team members, who are members, are members in good standing with IIA

Failure to submit all of the above mentioned document may result in the disqualification of the bid.

9. Verification documents for points claimed for specific goals;
 - a. Certified copies of company directors IDs,
 - b. CSD summary report not older than 1 month from the closing date,
 - c. Certified copy of CIPC Company registration document
 - d. Certified copy of valid BBBEE certificate

- e) Each panel member will rate each individual criterion as per the above point allocation scales:
- f) The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- g) This score will be converted to a percentage and only bidders that have met or exceeded the minimum threshold of 75% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.
- h) Any proposal not meeting a minimum score of 75 percent technical proposal will be regarded as non-responsive and it will not be evaluated further.

8. STAGE 2: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- a) In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be evaluated by MGSLG on the 80/20 – preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:
- The bid price (maximum 80 points)
 - Broad-Based Black Economic Empowerment as well as specific goals
 - (maximum 20 points)
- b) The following formula will be used to calculate the points for price in respect of bidders with a Rand value below R50 000 000.00:
- $$P_s = 80 \{1 - (P_t - P_{\min}) / (P_{\max} - P_{\min})\}$$

Where

Ps = Points scored for comparative price of bid under consideration

Pt = Comparative price of bid under consideration, inclusive of VAT

Pmin=Comparative price of lowest acceptable bid, inclusive of VAT

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

9. B-BBEE POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be below R50 Million in accordance with the formula and applicable points provided for in the respective status level contributor tables in the Regulations.

- i. The points scored by a bidder in respect of the points indicated above will be added to the points scored for price.
- ii. Bidders are requested to complete the various preference claim forms in order to claim preference points.
- iii. Only a bidder who has completed and signed the declaration part of the preference claim
- iv. form will be considered for B-BBEE Status.
- v. Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to B-BBEE Status.
- vi. Points scored will be rounded off to the nearest 2 decimals.
- vii. In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for B-BBEE Status. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored a highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots..
- viii. A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.

- ix. MGSLG reserves the right to arrange contracts with more than one contractor.
- x. MGSLG reserves a right to withdraw, cancel or not to award this tender.
- xi. The bidder should apply for registration on the MGSLG Supplier Database. Application forms for registration are available on the **MGSLG Website** www.mgslg.co.za . The duly completed application form should be submitted together with the proposal.

10. COMMUNICATION

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

11. PROHIBITION OF RESTRICTIVE PRACTICES

- a. In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:
 - Directly or indirectly fixing a purchase or selling price or any other trading condition
 - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
 - Collusive bidding.
- b. If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

12 FRONTING

- a. MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognises that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- b. MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to

determine that accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.

- c. The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliant with B-BBEE companies.

15. PRESENTATION

MGSLG may require presentation/interviews from shortlisted bidders as part of the bid process.

16. TIMEFRAMES AND FORMAL CONTRACT

Successful bidder(s) will be required to enter into formal contract with MGSLG for the period of one year, renewable annually for a maximum of 3 years.
