1. INTRODUCTION

The Matthew Goniwe School of Leadership and Governance (MGSLG), an agency of the Gauteng Department of Education (GDE), was established in 2003 to serve as the capacity-building arm of the GDE to provide empirical and research-based quality intervention programmes for School Governing Bodies (SGBs) and School Management Teams (SMTs). It has since expanded its scope to include District Officials, educators, learners (RCL members) and parents.

MGSLG is working closely with the Gauteng Department of Education to provide psycho-social support to Teachers and Learners in schools. A framework for the provision of this type of support has been developed and agreed to with all partners. MGSLG realizes the need to partner with various stakeholders. Additionally, MGSLG is required to contract the services of specialists, registered with the National Department of Social Development and accredited as Child Protection and Child Justice Organisations, to render on site prevention, early intervention and support services for learners in need of Psychosocial Support (PSS) and Social Work Services, and learners at risk of suspension and expulsion due to challenging behaviour, such as bullying and gangsterism.

The increasing rate of bullying, peer pressure, drug and substance abuse, rape, killings/murder, and other social ills in our schools has become a major social, systemic and management challenge for the smooth running of our schools and it impacts the lives of the thousands of young people involved, potentially limiting their personal growth, pursuit of rewarding careers and ambition. Violent incidents amongst learners, and educators as well, have accelerated to the point where it requires a systemic policy and structured implementation planning. Thus, the Multi-Certification Programme has been conceptualized with this mind, which is to come-up with developmental ways of getting our learners to be part of the solution. This programme will seek to address the growing incidents of several social ills; the social context within which they occur; what are the possible steps which are there to address these, how to manage these incidents etc.

2. PURPOSE

MGSLG intends to acquire the services of an experienced service provider or service providers to provide Psychosocial Support to Primary school learners (Grade 5 – 7) and capacitate educators (School Based Support Teams- SBST) in the Gauteng schools on Multi-Certification Project: Peer Mediation

Training of learners.

3. OBJECTIVES

The objectives of the programme are to appoint a credible service provider/s to:

- 3.1 Develop and deliver a comprehensive school-based programme on peer mediation under the multi-certification project targeting learners from GDE identified primary schools.
- 3.2 Design and develop a customized handbook and utilize the zero-rated mobile app installed already that will:
 - (a) Capacitate identified learners with skills that will enable them to be part of the Positive Peer Groups to play a critical role in discouraging or putting a stop to bullying or eliminating it.
 - (b) Provide information on prevention strategies for various types of violence and social ills in schools; provide care, counselling, and support to the affected learners; limit the impact of these incidents on learners within the framework of Care and Support for Teaching and Learning (CSTL).
 - (c) Help learners gain insight into the knowledge and skills to make conscious, healthy, and respectful choices about their lives and their future.
- 3.3 Create and drive an awareness campaign on peer mediation – by way of, but not limited to social media platforms, billboards, and murals to encourage learners and teachers alike to make conscious, healthy, and respectful choices about their lives and future.
- 3.4 Assist MGSLG in creating platforms that will support learners and capacitate teachers (SBST) on peer mediation processes, strategies, and procedures.
- 3.5 Conduct 18 learner support sessions over a period of 12 months.
- 3.6 Conduct 18 capacity building sessions for teachers over a period of 12 months.
- 3.7 Issue certificates of completion in GDE and MGSLG logos
- 3.8 Develop, implement, and monitor the effectiveness of the above strategies, systems and training programmes that promote wellness and prevent bullying and other related behaviours.

4. SCOPE OF SERVICES

The scope of services from the service provider is to:

- 4.1 Develop a comprehensive Peer Mediation support and training programme of 18 sessions over a period of 12 months as follows:
 - (a) support programme targeting Grade 5-7 learners in identified public ordinary and special schools as per the directive from GDE -One school per district and one learner per grade - in schools identified by GDE in 15 schools. This is envisaged as pilot programme to only 15 schools

in the province as directed by GDE.

(b) capacity building programme targeting educators (in SBST) in the 15 schools identified and submitted for the piloting schools.

4.2 Deliver training on prevention strategies to the participating schools which will be sourced from schools reported by GDE having reported high incidents of learners displaying aggressive behaviours (such as bullying, gangsterism, etc.).

4.3 Issue certificates of completion in the GDE and MGSLG logos. Certificates to be awarded for attending 80% of the scheduled sessions.

4.4 Develop Campaigns that will, but not limited to social media platforms, billboards and murals, to encourage learners and teachers alike to make conscious, healthy and respectful choices about their lives and future.

5. METHODOLOGY

5.1 Submit a detailed methodology explaining project execution and intervention processes that will cover all project scope of work and project milestones.

5.2 Outline a detailed timeline for each of the communication levels mentioned.

5.3 Develop a post training and support framework for monitoring use of skills in schools.

6. OUTPUTS AND DELIVERABLES

The following outputs and deliverables are expected from the appointed Service Provider:

6.1 Detailed Project plans.

6.2 Inception report detailing methodology and work plan.

6.3 Design and develop the booklet and zero-rated app (mentioned under the Objectives of the programme).

6.4 Detailed programme of action regarding the awareness campaigns envisioned.

6.5 Create targeted systems that will attract/stimulate the participation of learners in Grades 5, 6 and 7 (one learner per grade) in GDE identified schools - 1 school per district.

6.6 Award Certificates of completion in GDE and MGSLG logos. Certificates to be awarded for attending 80% of schedule sessions.

6.7 Display various anti-bullying posters, billboards and murals that have a QR code attached in schools and public spaces

6.8 Provide post training support after completion of each module, and monitoring of the application of skills.

6.9 Conduct skills transfer workshop to MGSLG and GDE Officials

6.10 Submit monitoring reports quarterly.

6.11 Submit close out report at the end of the project based on the prescribed MGSLG template.

7. EVALUATION PROCESS

The Evaluation Process comprises the following stages:

7.1 Pre-evaluation stage/ mandatory documents

- During this phase bid documents will be reviewed to determine compliance with tax matters and whether original and valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

Bidders must attach the following mandatory returnable documents in order to be considered for this bid:

- Original and valid tax clearance or Printed copy tax clearance certificate accompanied by a pin for further verification.
- Certified ID(s) copies of company director(s)
- Certified Proof of company registration
- Proof of registration on National Treasury Central Supplier Database (CSD) not older than one month.
- Company municipal rates, electricity or water account not older than three months, proof of Residential lease or rental or sworn affidavit if the business operates at a place of residence.
- Completed and signed Standard Bidding Document (SDB) attached in the tender document.
- Proof of company banking details e.g., bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.
- Company profile with a minimum of 5 years' experience in working in the relevant field.
- Registration with the HPCSA / Department of Social Development in line with the Legislative Prescripts

Failure to submit all of the above-mentioned documents will result to the disqualification of the bid.

7.2 Stage 1: Technical/Functionality Evaluation

a) Bids will be evaluated strictly according to the bid evaluation criteria stipulated in this section of the Terms of Reference (ToR). During this stage bidders' responses will be evaluated for functionality based on achieving a minimum score of seventy five percent (75%). Bidders who obtain less than 75% in the functionality points will be regarded as non-responsive and will be eliminated from the evaluation process.

b) Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated in this document. The panel responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.

c) Bidders will not rate themselves but need to ensure that all information is supplied as required. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify

all documents submitted by the bidders.

d) The panel members will individually evaluate the responses received against the following criteria as set out below:

- e) Each panel member will rate each individual criterion as per the above point allocation scales:
 - f) The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
 - g) This score will be converted to a percentage and **only** bidders that have met or exceeded the minimum threshold of 75% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.
- Any proposal not meeting a minimum score of 75 percent technical proposal will be regarded as non-responsive and it will not be evaluated further.

8. STAGE 2: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- a) In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be evaluated by MGSLG on the 80/20 – preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:
- ☐ The bid price (maximum 80 points)
 - ☐ Broad-Based Black Economic Empowerment as well as specific goals (maximum 20 points)
- b) The following formula will be used to calculate the points for price in respect of bidders with a Rand value below R50 000 000.00:

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration, inclusive of VAT

P_{\min} = Comparative price of lowest acceptable bid, inclusive of VAT

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

9. B-BBEE POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be below R50 Million in accordance with the formula and applicable points provided for in the respective status level contributor tables in the Regulations.

Failure to capture the required status level and to submit the certified or original B-BBEE status level certificates no points will be allocated to the service providers.

- a. The points scored by a bidder in respect of the points indicated above will be added to the points scored for price.
- b. Bidders are requested to complete the various preference claim forms in order to claim preference points.
- c. Only a bidder who has completed and signed the declaration part of the preference claim form will be considered for B-BBEE Status.
- d. Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to B-BBEE Status.
- e. Points scored will be rounded off to the nearest 2 decimals.
- f. In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for B-BBEE Status. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored a highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots..
- g. A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.
- h. ***MGSLG reserves the right to arrange contracts with more than one contractor.***
- i. ***MGSLG reserves a right to withdraw, cancel or not to award this tender.***

Failure to submit all of the above-mentioned documents will result to the disqualification of the bid.

The bidder should apply for registration on the MGSLG Supplier Database. Application forms for registration are available on the MGSLG Website www.mgslg.co.za . The duly completed application form should be submitted together with the proposal.

10. COMMUNICATION

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

11. PROHIBITION OF RESTRICTIVE PRACTICES

- a. In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:
 - Directly or indirectly fixing a purchase or selling price or any other trading condition
 - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
 - Collusive bidding.
- b. If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

12. FRONTING

- a. MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- b. MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine that accuracy of the representation made in bid documents. Should any of

the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.

- c. The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliant with B-BBEE companies.
