1. INTRODUCTION

The Matthew Goniwe School of Leadership and Governance (MGSLG), an agency of the Gauteng Department of Education (GDE), was established in 2003 to serve as the capacity-building arm of the GDE to provide empirical and research-based quality intervention programmes for School Governing Bodies (SGBs) and School Management Teams (SMTs). However, its scope has since been extended to include the training and development of district officials, educators, learners (RCL members) and parents.

Given the unprecedented disruptions of schooling and life in general due to the impact of the Covid-19 pandemic, it has become necessary for MGSLG to address the psychosocial challenges faced by our learners, teachers and their communities. MGSLG/GDE is partnering with NGOs in the child protection field to bring specialist psychosocial support to learners and teachers in schools. A framework for the provision of this type of support has been developed and agreed to with all partners.

A school is an ideal resource for teachers and learners to learn socio-emotional skills; it is the place where they socialize with people their age. It is the first place where they spend a significant number of hours without the interaction with and supervision of their relatives. That is why it is vital that schools take the opportunity to enhance the ability to manage emotions, self-control and how to relate to other people. Institutions must invest in prevention, offering timely and efficient care for children and young people's mental health problems.

2. PURPOSE

MGSLG intends to acquire the services of a specialist service provider/s for psychosocial support within the Child Protection and child justice field to provide school-based intervention(s) programmes for learners and teachers on suicide prevention, mental health issues, poverty, child headed, health and lifestyle issues affecting learners from schools.

3. OBJECTIVES

MGSLG is required to contract the services of specialists, registered with the National Department of Social Development and accredited as child protection and child justice organisations, to render on site prevention, early intervention and support services for learners in need of Psychosocial Support (PSS) and Social Work Services, and learners at risk of suspension and expulsion due to challenging behaviour, such as bullying and gangsterism.

The objectives of the programme are to appoint a credible service provider/s to:

- 3.1 Develop a comprehensive school-based intervention programme on suicide prevention targeting learners and teachers affected by mental health and other factors associated with suicidal ideation that is highly prevalent in South Africa.
- 3.2 Design and/or develop a customized booklet and zero-rated mobile app that will:
 - a) Guide teachers and learners on suicide prevention strategies - focusing on help-seeking, reducing stigma, encouraging positive behavioral change, informing them of available resources, and highlighting effective early interventions and support systems.
 - b) Promote socio-emotional and mental well-being.
- 3.3 To assist MGLSG and the GDE to ensure that the designed booklet and zero-rated app will promote suicide prevention activities-across multiple settings.
- 3.4 On behalf of MGSLG and the GDE communications directorate develop and create vigorous awareness campaigns that will be used for as part of a programme on suicide prevention – using social media platforms, billboards and murals to encourage learners and teachers alike to develop positive life skills and attitudes.
- 3.5 Develop material for use in class-based group sessions.
- 3.6 Develop a training programme for School Based Support Teams (SBSTs):
 - a) that will empower SBSTs on how to identify and support learners who are at risk of or experiencing mental health challenges and help prevent learner suicide.
 - b) Endorse the Programme with SACE for CPTD points on behalf of MGSLG
- 3.7 Deploy and utilize the services of professionally qualified Social Workers or Mental Health Practitioners who are also registered with the relevant authority.

This is with a view of offering counselling services to inculcate a belief and strategy that promotes seeking help from peers, adults, and experts in the field.
- 3.8 Develop, implement, and monitor the effectiveness of the above systems, intervention, and capacity building programmes.

4. SCOPE OF SERVICES

MGSL requires specialist service provider/s in the field of Child Protection and Child Justice to:

- 4.1 Develop a comprehensive school-based intervention programme on suicide prevention.
- 4.2 Design and develop a customized booklet and a zero-rated app that will guide teachers and learners on suicide prevention strategies.
- 4.3 Create vigorous awareness campaigns on suicide prevention to promote positive life skills and attitudes.
- 4.4 Design and develop a training programme that will empower SBSTs (teachers) on how to identify and support learners who are at risk of or experiencing mental health problems to prevent learner

suicide.

(a) Endorse the Programme on behalf of MGSLG with SACE

4.5 Issue certificates of completion. Certificates to be awarded for attending 80% of schedule capacity building session in the GDE and MGSLG logos.

4.6 The programme should run for a period twelve (12) months.

5. METHODOLOGY

5.1 Submit a detailed methodology explaining project execution process that will cover all project scope of work and project milestones.

5.2 Develop a detailed timeline framework for each of the communication levels.

5.3 Develop a post training and support framework for monitoring use of skills in schools.

6. OUTPUTS AND DELIVERABLES

The following outputs and deliverables are expected from the service provider/s:

6.1. Detailed project plan.

6.2. An Inception report detailing methodology and work plan.

6.3. A well-articulated and designed booklet; and a zero-rated app (as mentioned under the Objectives of the programme).

6.4. A detailed programme of action regarding the awareness campaigns envisioned.

6.5. Deliver the training programme to SBST members from identified Sedibeng and Ekurhuleni schools as per the GDE directive in support of other programmes of support offered to other schools in the province.

6.6. Deliver training to learners from identified Sedibeng and Ekurhuleni schools as the directive from GDE.

6.7. Commission the services of professionally qualified social workers or mental health practitioners who are registered with the relevant authority to support learners who have been identified and affected with suicide ideation and mental health challenges.

6.8. Provide a detailed plan of post training support and monitoring of the application of skills.

6.9. Submit monthly post capacity building reports.

6.10. Submit a close out report at the end of the project based on the prescribed MGSLG template.

7. EVALUATION PROCESS

The Evaluation Process comprises the following stages:

7.1 Pre-evaluation stage/ mandatory documents

- During this phase bid documents will be reviewed to determine compliance with tax matters and whether original and valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

Bidders must attach the following mandatory returnable documents in order to be considered for this bid:

- Original and valid tax clearance or Printed copy tax clearance certificate accompanied by a pin for further verification.
- Certified ID(s) copies of company director(s)
- Certified Proof of company registration
- Proof of registration on National Treasury Central Supplier Database (CSD) not older than one month.
- Company municipal rates, electricity, or water account not older than three months, proof of Residential lease or rental or sworn affidavit if the business operates at a place of residence.
- Completed and signed Standard Bidding Document (SDB) attached in the tender document.
- Proof of company banking details e.g., bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.
- Company profile with a minimum of 5 years' experience in working in the relevant field.
- Provide proof of their staff-vetting against and clearance from the child protection and sexual offences registers

Failure to submit all of the above-mentioned document will result to the disqualification of the bid.

The bidder should apply for registration on the MGSLG Supplier Database. Application forms for registration are available on the MGSLG Website www.mgslg.co.za. The duly completed application form should be submitted together with the proposal.

7.2 Stage 1: Technical/Functionality Evaluation

a) Bids will be evaluated strictly according to the bid evaluation criteria stipulated in this section of the Terms of Reference (ToR). During this stage bidders' responses will be evaluated for functionality based on achieving a minimum score of seventy five percent (75%). Bidders who obtain less than 75% in the functionality points will be regarded as non-responsive and will be eliminated from the evaluation process.

b) Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated in this document. The panel responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.

c) Bidders will not rate themselves but need to ensure that all information is supplied as required. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify all documents submitted by the bidders.

d) The panel members will individually evaluate the responses received against the following criteria as set out below:

- e) Each panel member will rate each individual criterion as per the above point allocation scales:
- f) The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- g) This score will be converted to a percentage and only bidders that have met or exceeded the minimum threshold of 75% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.
- Any proposal not meeting a minimum score of 75 percent technical proposal will be regarded as non-responsive and it will not be evaluated further.

8. STAGE 2: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- a) In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be evaluated by MGSLG on the 80/20 – preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:
- ☐ The bid price (maximum 80 points)
 - ☐ Broad-Based Black Economic Empowerment as well as specific goals (maximum 20 points)
- b) The following formula will be used to calculate the points for price in respect of

bidders with a Rand value below R50 000 000.00:

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration, inclusive of VAT

P_{\min} = Comparative price of lowest acceptable bid, inclusive of VAT

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

9. B-BBEE POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be below R50 Million in accordance with the formula and applicable points provided for in the respective status level contributor tables in the Regulations.

Failure to capture the required status level and to submit the certified or original B-BBEE status level certificates no points will be allocated to the service providers.

- a. The points scored by a bidder in respect of the points indicated above will be added to the points scored for price.
- b. Bidders are requested to complete the various preference claim forms in order to claim preference points.
- c. Only a bidder who has completed and signed the declaration part of the preference claim form will be considered for B-BBEE Status.
- d. Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to B-BBEE Status.
- e. Points scored will be rounded off to the nearest 2 decimals.
- f. In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for B-BBEE Status. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored a highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots..
- g. A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.
- h. ***MGSLG reserves the right to arrange contracts with more than one contractor.***
- i. ***MGSLG reserves a right to withdraw, cancel or not to award this tender.***

Failure to submit all of the above mentioned documents will result to the disqualification of the bid.

10. COMMUNICATION

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

11. PROHIBITION OF RESTRICTIVE PRACTICES

- a. In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:
 - Directly or indirectly fixing a purchase or selling price or any other trading condition
 - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
 - Collusive bidding.
- b. If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

12. FRONTING

- a. MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognises that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- b. MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine that accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.
- c. The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliant with B-BBEE companies.
