## 1. INTRODUCTION

The Matthew Goniwe School of Leadership and Governance (MGSLG) is a development institute that provides learning programmes in the education sector to enable quality teaching and learning in schools. Its vision is "To be the Leading Development Institute in the Education Sector".

MGSLG is a registered Section 21, Non-Profit Company, established to research, develop and deliver cutting edge capacity building programmes using ICT in the areas of **school management & leadership, school governance and teacher development** for capacity building of School Management Teams (SMTs), School Governing Bodies (SGBs), Representative Council of Learners (RCLs), Teachers and other stakeholders in the public education sector within the Gauteng Province.

The institution is located at two main campuses, at Vrededorp which serves as the Head Office and at Benoni, which is distinguished as the ICT Training Centre.

The focus of our work is in the areas of:

- Professional growth of educators and school governors.
- School leadership and management development.
- Improving education practice through research.
- Capacity-building initiatives relating to new education policy initiatives and
- Teacher-up-skilling.

Our mandate is fully aligned to the vision and mission of the Gauteng Department of Education (GDE), "***to ensure every learner feels valued and inspired in our innovative education system.***" In order to attain the afore-stated vision, the GDE has set out five strategic goals and supporting priorities all aimed at transforming the education landscape and targeting the achievement of quality teaching and learning outcomes by enhancing the skills and competencies of Educators, School Management Teams (SMTs) as well School Governing Bodies (SGBs). These notable policy and administrative reforms by the GDE also include curriculum reviews, resource redistribution as well as ICT necessitated sector wide changes.

## 2. PURPOSE

MGSLG intends to acquire the services of experienced service provider(s) to assist to provide school improvement programmes for underperforming schools for a period of three years

aimed to improve learner outcomes. This is a specialized project, it therefore, does not intend replacing any of MGSLG's existing programmes.

### **3. OBJECTIVES**

The specific objectives of this programme are: to improve the whole schools' ecosystem and focus on these areas:

- To assist the MGSLG to provide services through targeted teacher development programmes that will result in improved quality of teaching and learning in underperforming schools as per the nine focus areas on the WSE.
- To capacitate SMT's in identified schools in curriculum management strategies that will promote performance and enhance accountability.
- Tracking of learner performance and attainment.
- Provision of on-site and online support programmes to coach school management teams and staff to assess their own progress against targeted outcomes.
- Develop a refined and a sustainable model/framework for supporting underperforming/ schools for the Gauteng Province.
- Assist with Professional development of stakeholders including GDE officials on multiple subjects and multi-grade teaching support strategies.
- Identification and resolution of issues which negatively impact on the Performance of selected underperforming schools.
- Provide Families involved parents/ guardians with skills and strategies to be better support partners to their children.
- To provide tools that will enable sustainable whole school improvement, including Psychosocial Support.

### **4. SCOPE OF WORK**

In keeping with the project objectives, the service provider(s) will be required to diagnose unique challenges for each school and develop implementation plans for their resolution.

What will be covered:

- To conduct Internal Whole School Evaluation to Needs Analysis of targeted schools To conduct research through the use of WSE tools and processes to ascertain the needs of

each school including socio-economic factors impacting on under/ non-performance. An implementation plan must be developed based on the findings

- Training and support of teachers, parents/guardians and office-based staff in the GDE responsible for the targeted schools
- Build relationships that will enhance teacher performance
- Monitoring and tracking of performance in line with the Proposed Theory of Change and the Logic Framework
- Reporting and ongoing project review
- Conduct two Seminars on School Improvement education (One per year)
- Establishment of functional PLCs that will make a positive impact on teaching and learning in the targeted schools.
- Integrate ICT to expand options for students and teachers
- Promote Community participation in the project schools.

**Target:**

- 35 schools targeting learners, teachers, and instructional leadership
- An estimated 6000 Parents/guardians and SGB's distributed proportionally among the above mentioned schools

**5. PRE-QUALIFICATION COMPETENCIES**

5.1 The bidder must be practitioners or former practitioners within the Education Sector. (The bidder must provide documentary proof of their registration/affiliation to any credible accrediting body or ETQA.

5.2 The bidder must certify that they are independent of MGSLG/GDE and that nothing has transpired that would compromise their independence during the project implementation.

**6. OUTPUTS AND DELIVERABLES**

The service provider will be expected to:

- To conduct training needs analysis to define instructional problems meeting pre-determined standards.

- Design the learning and development programme in consultation with the internal and external stakeholders to ensure quality outputs. The design must meet programme design quality standards.
- Development of learning programme and support materials in line with the design matrices and piloted for quality assurance and must meet set standards.
- Implementing the training according to project management principles
- Implement continuous monitoring process that starts at the beginning and ends with synthesis evaluation. Monitoring and evaluation tools must be developed during the design and/or review phase.
- The Service Provider will be expected to submit monthly & quarterly progress reports to the Project Manager for the duration of the project.

## **7. REQUIRED EXPERTISE:**

The service provider team should consist of consultant(s) who meet the minimum of the following requirements:

- Advanced University degree (Masters or PhD) in Education, Social Science and any other relevant fields (essential).
- At least 5-10 years institutional demonstrated experience in undertaking school improvement project or similar (essential).
- CVs of involved professionals should be made available upon submission of application (essential).
- Over 5 years' experience of working in senior management roles in education projects in similar contexts (essential).
- Advanced skills in Research Methodologies (essential).
- Excellent communication skills including report writing & presentation (essential).
- Experience in engaging directly with principals, teachers, parents/guardians, SGBs & learners in the context of programme delivery, research and analysis, with proven background in conducting such analysis (preferred).
- Proven experience in monitoring and evaluation (essential).

## **8. COPYRIGHT AND CONFIDENTIALITY**

Training materials developed in the course of this project will be the sole property of the MGSLG and may not be shared with anyone without prior written permission to do so.

The service provider will at all times and for all purposes, regard as strictly confidential all

knowledge and information not within public domain which may be acquired in the course of carrying out this project and shall not be directly or indirectly disclosed to any person whatsoever, except with the written permission of MGSLG.

## 9. EVALUATION PROCESS

The Evaluation Process comprises the following stages:

### 9.1 Pre-evaluation stage/ mandatory documents

- During this phase bid documents will be reviewed to determine compliance with tax matters and whether original and valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

Bidders must attach the following mandatory returnable documents in order to be considered for this bid:

- Original and valid tax clearance or Printed copy tax clearance certificate accompanied by a pin for further verification.
- Certified ID(s) copies of company director(s).
- Certified Proof of company registration.
- Company municipal rates, electricity or water account not older than 3 Months, proof of Residential lease or rental or sworn affidavit if the business operates at a place of residence.
- Completed and signed Standard Bidding Document (SDB) attached in the tender document.
- Proof of registration on National Treasury Central Supplier database.
- Proof of company banking details.
- Company profile with a minimum of 5 years' experience working in the relevant field.
- Proof of company banking details e.g. bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.

***Failure to submit all of the above mentioned document will result to the disqualification of the bid.***

## 9.2 Stage 1: Technical/Functionality Evaluation

- a) Bids will be evaluated strictly according to the bid evaluation criteria stipulated in this section of the Terms of Reference (ToR). During this stage bidders' responses will be evaluated for functionality based on achieving a minimum score of seventy five percent (75%). Bidders who obtain less than 75% in the functionality points will be regarded as non-responsive and will be eliminated from the evaluation process.
- b) Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated in this document. The panel responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.
- c) Bidders will not rate themselves, but need to ensure that all information is supplied as required. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify all documents submitted by the bidders.
- d) The panel members will individually evaluate the responses received against the following criteria as set out below:

- e) Each panel member will rate each individual criterion as per the above point allocation scales:
- f) The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- g) This score will be converted to a percentage and **only** bidders that have met or exceeded the minimum threshold of 75% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.
- h) Any proposal not meeting a minimum score of 75 percent technical proposal will be regarded as non-responsive and it will not be evaluated further.

## 10. STAGE 2: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- a) In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be evaluated by MGSLG on the 80/20 – preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:
  - o The bid price (maximum 80 points)
  - o Broad-Based Black Economic Empowerment as well as specific goals (maximum 20 points)
- b) The following formula will be used to calculate the points for price in respect of bidders with a Rand value below R50 000 000.00:

$$P_s = 80 \left\{ 1 - \frac{(P_t - P_{\min})}{(P_{\min})} \right\}$$

Where:

$P_s$  = Points scored for comparative price of bid under consideration.

$P_t$  = Comparative price of bid under consideration, inclusive of VAT.

Pmin=Comparative price of lowest acceptable bid, inclusive of VAT.

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

### 11. B-BBEE POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be below R1 Million in accordance with the formula and applicable points provided for in the respective status level contributor tables in the Regulations.

Failure to capture the required status level and to submit the certified or original B-BBEE status level certificates no points will be allocated to the service providers.

- a) The points scored by a bidder in respect of the points indicated above will be added to the points scored for price.
- b) Are requested to complete the various preference claim forms in order to claim preference points.
- c) Only a bidder who has completed and signed the declaration part of the preference claim form will be considered for B-BBEE Status.
- d) Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to B-BBEE Status.
- e) Points scored will be rounded off to the nearest 2 decimals.
- f) In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for B-BBEE Status. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored a highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots..
- g) A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.
- h) ***MGSLG reserves the right to arrange contracts with more than one contractor.***
- i) ***MGSLG reserves a right to withdraw, cancel or not to award this tender.***

**Failure to submit all of the above-mentioned documents will result to the disqualification of the bid.**

## **12. COMMUNICATION**

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

## **13. PROHIBITION OF RESTRICTIVE PRACTICES**

- a) In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association

of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:

- Directly or indirectly fixing a purchase or selling price or any other trading condition
  - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
  - Collusive bidding.
- b) If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

#### **14. FRONTING**

- a. MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- b. MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine that accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.
- c. The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliant with B-BBEE companies.

### **31. DECLARATION CERTIFICATE FOR LOCAL PRODUCTION AND CONTENT FOR DESIGNATED SECTORS**
