#### 1. INTRODUCTION

The Matthew Goniwe School of Leadership and Governance (MGSLG) is a development institute that provides learning programmes in the education sector to enable quality teaching and learning in schools. MGSLG's vision is: "To be the Leading Development Institute in the Education Sector."

MGSLG is a registered Section 21, Non-Profit Company, established to research, develop, and deliver cutting-edge capacity-building programmes using ICT in **School Management & Leadership, School Governance**, and **Teacher Development**. The programs are designed for capacity building of School Management Teams (SMT), School Governing Bodies (SGB), Representative Council of Learners (RCL), Teachers, and other stakeholders in the public education sector within the Gauteng Province.

The institution is located at two main campuses, at Vrededorp, which serves as the Head Office, and at Benoni, which is distinguished as the ICT Training Centre.

The focus of our work is in the areas of:

- Professional growth of educators and school governors.
- School leadership and management development.
- Improving education practice through research.
- Capacity-building initiatives relating to new education policy initiatives and
- Teacher-up-skilling.

Our mandate is fully aligned with the vision and mission of the Gauteng Department of Education (GDE), "to ensure every learner feels valued and inspired in our innovative education system." To attain the afore-stated vision, the GDE has set out five strategic goals and supporting priorities, all aimed at transforming the education landscape and targeting the achievement of quality teaching and learning outcomes by enhancing the skills and competencies of the educators, SMTs, SGBs and office-based educators. These notable policies and administrative reforms by GDE also include curriculum reviews, resource redistribution as well as ICT necessitated sector-wide changes.

#### 2. PURPOSE

MGSLG intends to acquire the services of experienced service provider(s) to design, develop,
 and implement the training programme for the office-based educators (SES, IDSO, CM & CES).





• The implementation of this programme will assist to improve the interface between the districts and schools; and ultimately improve the quality of academic learner outcomes.

# 3. OBJECTIVES

The specific objective of the programme is:

 To develop a needs based developmental programme that will assist office-based educators to better support school principals, school management teams, and school governing bodies in the management, administration, and governance of schools.

# 4. SCOPE OF SERVICES

The scope of this programme includes:

- 4.1. To conduct a qualitative and quantitative baseline study to inform project interventions.
- 4.2. To develop a training programme and relevant training materials including assessment tools that can be delivered in a virtual and face-to-face format compatible to the MGSLG learning platforms.
- 4.3. To develop a practical district handbook/toolkit or district officials (office-based educators).
- 4.4. To accredit the training programme with the relevant ETQA body on behalf of MGSLG.
- 4.5. Upon completion of the development of the content, have the capacity (training of facilitators and, production of material) and ability to deliver the above programme
- 4.6. Convene monthly meetings to present the progress reports with the relevant stakeholders.
- 4.7. Convene a workshop on the close out report with the relevant stakeholders.
- 4.8. Submission of the monthly reports and the close-out report on the MGSLG provided templates.

# 5. METHODOLOGY

It is expected that the service providers must submit a detailed project execution document which should entail:





- a. Submit a clear and well-articulated proposal on the design, development and training methods and timeline for capacitating various stakeholders.
- b. A detailed timeline for each of the project implementation steps to be delivered should be indicated.
- c. Develop the training material for both online and face to face
- d. Assess and moderate all participants and additional participants that may be allocated to the project by the GDE for assessment in line with the SETA requirements
- e. Conduct post training certification ceremonies.
- f. Submit a close out report at the end of the Programme.

# 7. EVALUATION PROCESS

Evaluation Process comprises the following stages:

# 7.1 Pre-evaluation stage/ mandatory documents

• During this phase bid documents will be reviewed to determine compliance with tax matters and whether original and valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

Bidders must attach the following mandatory returnable documents in order to be considered for this bid:

 Original and valid tax clearance or Printed copy tax clearance certificate accompanied by a pin for further verification.





- Certified ID(s) copies of company director(s)
- Certified Proof of company registration
- Proof of registration on National Treasury Central Supplier Database (CSD) not older than one month.
- Company municipal rates, electricity or water account not older than three months, proof of Residential lease or rental or sworn affidavit if the business operates at a place of residence.
- Completed and signed Standard Bidding Document (SDB) attached in the tender document.
- Proof of company banking details e.g. bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.
- Company profile with a minimum of 5 years' experience in working in the relevant field.

Failure to submit all of the above-mentioned document will result to the disqualification of the bid.

# 7.2 Stage 1: Technical/Functionality Evaluation

- a) Bids will be evaluated strictly according to the bid evaluation criteria stipulated in this section of the Terms of Reference (ToR). During this stage bidders' responses will be evaluated for functionality based on achieving a minimum score of eighty (80%). Bidders who obtain less than 80% in the functionality points will be regarded as non-responsive and will be eliminated from the evaluation process.
- **b)** Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated in this document. The panel responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.
- c) Bidders will not rate themselves but need to ensure that all information is supplied as required. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify all documents submitted by the bidders.
- **d)** The panel members will individually evaluate the responses received against the following criteria as set out below:

- e) Each panel member will rate each individual criterion as per the above point allocation scales:
- f) The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- g) This score will be converted to a percentage and only bidders that have met or exceeded the minimum threshold of 80% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.





**h)** Any proposal not meeting a minimum score of 80 percent technical proposal will be regarded as non-responsive and it will not be evaluated further.

# 8. STAGE 2: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- a) In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be evaluated by MGSLG on the 80/20 preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:
  - The bid price (maximum 80 points)
  - Broad-Based Black Economic Empowerment as well as specific goals (maximum 20 points)
- b) The following formula will be used to calculate the points for price in respect of bidders with a Rand value below R50 000 000.00:

Where

Ps = Points scored for comparative price of bid under consideration

Pt = Comparative price of bid under consideration, inclusive of VAT

Pmin=Comparative price of lowest acceptable bid, inclusive of VAT

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

#### 9. B-BBEE POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be below R50 Million in accordance with the formula and applicable points provided for in the respective status level contributor tables in the Regulations.

Failure to capture the required status level and to submit the certified or original B-BBEE status level certificates no points will be allocated to the service providers.

- **a.** The points scored by a bidder in respect of the points indicated above will be added to the points scored for price.
- **b.** Bidders are requested to complete the various preference claim forms in order to claim preference points.
- **c.** Only a bidder who has completed and signed the declaration part of the preference claim form will be considered for B-BBEE Status.
- **d.** Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to B-BBEE Status.
- e. Points scored will be rounded off to the nearest 2 decimals.
- f. In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for B-BBEE Status. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored a highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots..
- **g.** A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.
- h. MGSLG reserves the right to arrange contracts with more than one contractor.
- i. MGSLG reserves a right to withdraw, cancel or not to award this tender.

Failure to submit all of the above mentioned documents will result to the disqualification of the bid.

The bidder should apply for registration on the MGSLG Supplier Database. Application forms for registration are available on the MGSLG Website <a href="www.mgslg.co.za">www.mgslg.co.za</a> . The duly completed application form should be submitted together with the proposal.





# 10. COMMUNICATION

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

#### 11. PROHIBITION OF RESTRICTIVE PRACTICES

- **a.** In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:
  - Directly or indirectly fixing a purchase or selling price or any other trading condition
  - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
  - Collusive bidding.
- **b.** If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

# 12.FRONTING

- **a.** MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognises that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- b. MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine that accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.
- **c.** The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliant with B-BBEE companies.





#### 13. COMPULSORY BRIEFING

This session will provide bidders an opportunity to clarify certain aspects of the process as set out in this document and to address any substantial issues they might have.

# 21. TAX CLEARANCE CERTIFICATE REQUIREMENTS

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

- In order to meet this requirement bidders are required to complete in full the attached form TCC 001"Application for a Tax Clearance Certificate" and submit it to any SARS branch office nationally. The Tax Clearance Certificate Requirements are also applicable to foreign bidders / individuals who wish to submit bids.
- 2. 2 SARS will then furnish the bidder with a Tax Clearance Certificate that will be valid for a period of 1 (one)
  - year from the date of approval.
- 3. The original Tax Clearance Certificate must be submitted together with the bid. Failure to submit the original and valid Tax Clearance Certificate will result in the invalidation of the bid. Certified copies of the Tax Clearance Certificate will not be acceptable.
- 4. In bids where Consortia / Joint Ventures / Sub-contractors are involved, each party must submit a separate
  - Tax Clearance Certificate.
