1. INTRODUCTION

Matthew Goniwe School of Leadership and Governance (MGSLG) has been commissioned by the Gauteng Department of Education (GDE) to deliver ICT training and development for educators in the Province. Gauteng Department of Education has placed Information Communication Technology (ICT) as an enabler in the improvement of quality teaching and learning. In pursuit of this, GDE has undertaken a major investment in resourcing public schools with ICT infrastructure under the Schools of the Future Project. Major strides have been achieved and there is still a need for the training and capacity building of teachers and officials to enable them to purposely utilize these digital resources and realize significant pedagogic value in their use in schools. For the period 2020-2024 the Province has identified 16 000 educators who require capacitation with regards to the use of ICTs for teaching and learning. MGSLG is targeting 2 000 teachers from ICT implementing schools to be trained and capacitated on the use of digital tools and resources for the 2021/24 Financial Year subject to the availability of funds. To ensure quality and efficiency in reaching this target MGSLG require experienced and competent teacher professional development providers to manage and deliver this programme.

2. PURPOSE

The purpose of this process is to secure the services of an agency with competence and experience to assist with the provision of onsite support and training to 602 ICT implementing schools in the Province. The main purpose of this programme is to capacitate teachers and officials on the use of devices, integration of ICTs into specific subject specializations, mediation of DBE and GDE freely available content platforms and training on the use of virtual platforms to provide out of school support. The scope of training will be limited to the 15 districts in Gauteng Province targeting the following category of schools, Full ICT schools, Schools of Specialization and Technical High schools, LSEN, Twinning as well as Fee and Non-Fee Paying ICT implementing schools. The agency should be able to provide onsite support and training and be able to utilize alternative forms of providing professional teacher development through online platforms, remote platforms (MS Teams and Zoom) and use of video conferencing equipment. The service provider will be required to produce subject specific training materials through offline resources as well as online platforms. The agency will be required to produce a management plan in line with the agreed PELRC training schedule. This is a one year contract beginning 1st July 2021-30 June 2022 in which the Service Provider will be required to train at least 2 000 teachers across the Province.

3. OBJECTIVES

The objective of the program is to:

- Provide ICT integration support and training to teachers in the ICT implementing schools across the Gauteng Province
- Provide Digital Literacy and Virtual Education to 2 000 teachers in Identified schools
- Use the Project Based Learning as a framework to conduct training.
- Establish Professional Learning Communities in schools and support their functionality
- Provide online professional development to teachers and officials
- Develop digital specific subject materials to advance teaching and learning in key gateway subjects that includes Mathematics; Physical Science; Accounting; Geography; Technical Mathematics & Technical Science and Engineering Graphic & Design from Grade 8-12
- Appoint competent ICT facilitators to deliver training and support on the implementation of ICT project in

schools

- Capacitate ICT facilitators with the necessary skills and competencies on the use of modern digital technologies to advance teaching and learning
- Appoint coordinators to manage and supervise the implementation of the project at district and regional levels
- Provide weekly, monthly and quarterly reports on the implementation of the project

4. SCOPE OF SERVICES

To provide onsite support and training for ICT implementing schools in Gauteng that are supported by MGSLG under the guidance of the GDE. The training and management agency will have to fulfil the following responsibilities:

- Provide online and onsite support and training in ICT integration to ICT implementing schools that includes:
 - Teachers Online developmental Programmes from 16h00 – 19h00 (weekdays) and onsite support and training from 08h00 – 15h00 (weekdays) focusing on the following:
 - ✓ the application of available ICT digital tools and resources,
 - ✓ mediation of DBE and GDE freely available e-content,
 - ✓ digital assessment tools and methods
 - ✓ open sources available on the internet
- Provide training and support in project based learning that includes:
 - Application of digital devices to advance teaching and learning
 - Introduction to Project Based Learning approach
 - Project Based Learning processes and tools
 - Assessment in Project Based Learning environments
- Facilitate the development of Professional Learning Communities of practice amongst teachers by:
 - establishing Professional Learning Community in identified schools
 - coordinating online Professional Learning Communities
 - Institutionalization of Professional Learning Communities in schools
 - Functionality and sustaining Professional Learning Communities in schools
- Recruit, deploy and manage ICT trainers in compliance with the Labour Laws of the country who will provide ICT training and support to the teachers
- Recruit and manage experienced Regional Coordinators in compliance with the Labour Laws of the country who will mentor, train, monitor and manage the ICT trainers deployed in schools

5. METHODOLOGY

The service provide must provide a detailed methodology explaining project execution process that will cover all the project scope of work and project milestones. The methodology must show time line throughout the project lifecycle. The bidder must provide a methodology that demonstrate an understanding of ICT integration for teaching and learning.

5.1 PRE-QUALIFICATION COMPETENCIES & EXPERTISE REQUIREMENTS

The selection criteria to assess the technical capacity of the consultant/service provider includes the following:

- 5.1.1. A Project Leader should hold at least an advanced university degree (Masters or Higher) in Education, Social Science or any other subject relevant to education.
- 5.1.2. At least 5 years of relevant experience in Teacher Development or e-Learning professional development for teachers.

- 5.1.3. The Qualified bidder should have knowledge of project management.
- 5.1.4. The Qualified bidder should have team members who are qualified (experience and qualifications) to provide the training programmes with relevant experience to teacher professional development.
- 5.1.5. The Qualified bidder should exhibit the first-hand experience of working on training projects in collaboration with the education sector, other organizations and providers.
- 5.1.6. The Qualified bidder should demonstrate how they will incorporate 21st-century skills for teachers in their Programmes which include the integration of ICTs in the classroom.
- 5.1.7. Effective time management and organizational skills to ensure qualitative outputs under strict deadlines.

6. OUTPUTS AND DELIVERABLES

This will be a collaborative venture which will mean that both parties (MGSLG and the service provider) play their roles in order for the project to succeed. The successful bidder will be required to form a Joint Venture/Partnership with historically disadvantaged youth owned enterprises.

This will entail the following services:

6.1 Service Provider Roles:

- Training of Teachers and supporting 602 schools through onsite support and training in digital literacy and virtual education , subject specific ICT integration , mediation of e-learning content (DBE and GDE freely available content)
- Administer a needs analysis prior to training intervention in specific schools and compile a skills gap report for MGSLG
- Provide both online and contact sessions training to educators in the 602 schools.(Blended training)
- Design needs driven ICT integration intervention
- Provide online teacher professional development to teachers (minimum 30 hrs. per teacher)and provide evidence for such training (csv files or google forms)
- Develop digital subject specific training materials for key subjects from Grade 8-12(which will remain a property of MGSLG after the termination of the contract)
- Train teachers in Project Based Learning and Problem Based Learning
- Provide mobile classroom training and support to rural and mobile schools
- Train and provide support to School Based ICT Committees and provide MGSLG with proof through registers and datasets
- Coordinate online Professional Learning Communities of practice
- Contract ICT trainers selected to participate in this project
- Contracting Regional Coordinators to manage the project
- Payment of salaries against deliverables (time-sheets and reports) in compliance with the Labour Laws of the Country
- Monitoring and evaluation of the ICT trainer work related conduct and provide MGSLG with quarterly reports on the performance of each trainer
- Managing administrative work related to ICT trainers:
 - Deployment and Scheduling
 - Registration forms and attendance registers which includes online forms
 - Verification of all supporting documents related to training and support
 - Registers of trainers attending Professional Development
 - Maintain work Log sheets for each trainer and submit monthly reports on the prescribed template

- Quality Assurance:
 - Collection, coalition and submission of weekly training reports for reporting purpose on trainer and District Coordinator practices
 - Analysis of Weekly and monthly reports from District Coordinators
 - Consolidation and verification of quarterly datasets on the number of teachers trained
 - Submission of monthly compliance reports to the Project Manager and quarterly evidence reports to the RPQA Branch of MGSLG
- Attendance in PIT and Work Stream Meetings by invitation
- Close Out Report at the end of the project

6.2 MGSLG Roles:

- Monitor the management of ICT trainers feedback and professional development meetings
- Monitoring, evaluation and implementation of intervention strategies in schools and districts
- Monitor and guide implementation of ICT training in schools and districts
- Monitor compliance to MGSLG and GDE policies on training and development of Teachers
- Attendance in PIT and Work streams meetings

7. EVALUATION PROCESS

The Evaluation Process comprises the following stages:

7.1 Pre-evaluation stage/ mandatory documents

- During this phase bid documents will be reviewed to determine compliance with tax matters and whether original and valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

Bidders must attach the following mandatory returnable documents in order to be considered for this bid:

- Original and valid tax clearance or Printed copy tax clearance certificate accompanied by a pin for further verification.
- Certified ID(s) copies of company director(s)
- Certified Proof of company registration
- Company municipal rates, electricity or water account not older than 3 Months, proof of Residential lease or rental or sworn affidavit if the business operates at a place of residence.
- Completed and signed Standard Bidding Document (SDB) attached in the tender document.
- Proof of registration on National Treasury Central Supplier database.
- Proof of company banking details
- Company profile with a minimum of 5 years' experience in working in the relevant field.
- Proof of company banking details e.g. bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.

Failure to submit all of the above mentioned document will result to the disqualification of the bid.

7.2 Stage 1: Technical/Functionality Evaluation

- a) Bids will be evaluated strictly according to the bid evaluation criteria stipulated in this section of the Terms of Reference (ToR). During this stage bidders' responses will be evaluated for functionality based on achieving a minimum score of seventy five percent (75%). Bidders who obtain less than 75% in the functionality points will be regarded as non-responsive and will be eliminated from the evaluation process.
- b) Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated in this document. The panel responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.
- c) Bidders will not rate themselves, but need to ensure that all information is supplied as required. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify all documents submitted by the bidders.
- d) The panel members will individually evaluate the responses received against the following criteria as set out below:

- e) Each panel member will rate each individual criterion as per the above point allocation scales:
 - f) The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
 - g) This score will be converted to a percentage and **only** bidders that have met or exceeded the minimum threshold of 75% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.
- Any proposal not meeting a minimum score of 75 percent technical proposal will be regarded as non-responsive and it will not be evaluated further.

8. STAGE 2: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- a) In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be evaluated by MGSLG on the 80/20 – preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:
- ☐ The bid price (maximum 80 points)
 - ☐ Broad-Based Black Economic Empowerment as well as specific goals (maximum 20 points)

- b) The following formula will be used to calculate the points for price in respect of bidders with a Rand value below R50, 000,000.00:

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration, inclusive of VAT

P_{\min} = Comparative price of lowest acceptable bid, inclusive of VAT

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

- c) MGSLG reserves the right to arrange contracts with more than one contractor.

9. B-BBEE POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be above R1 Million in accordance with the formula and applicable points provided for in the respective status level contributor tables in the Regulations.

Failure to capture the required status level and to submit the certified or original B-BBEE status level certificates no points will be allocated to the service providers.

- a. The points scored by a bidder in respect of the points indicated above will be added to the points scored for price.
- b. Bidders are requested to complete the various preference claim forms in order to claim preference points.
- c. Only a bidder who has completed and signed the declaration part of the preference claim form will be considered for B-BBEE Status.
- d. Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to B-BBEE Status.
- e. Points scored will be rounded off to the nearest 2 decimals.
- f. In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for B-BBEE Status. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored a highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots..
- g. A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.
- h. ***MGSLG reserves a right to withdraw, cancel or not to award this tender.***

Failure to submit all of the above mentioned documents will result to the disqualification of the bid.

The bidder should apply for registration on the MGSLG Supplier Database. Application forms for registration are available on the MGSLG Website www.mgslg.co.za . The duly completed application form should be submitted together with the proposal.

10. COMMUNICATION

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

11. PROHIBITION OF RESTRICTIVE PRACTICES

- a. In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:
 - Directly or indirectly fixing a purchase or selling price or any other trading condition
 - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
 - Collusive bidding.
- b. If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

12. FRONTING

- a. MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognises that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- b. MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine that accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.
- c. The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliance with BBBEE companies.

13. COMPULSORY BRIEFING

There will be no briefing session for this tender.

14. PRESENTATION

MGSLG may require presentation/interviews from shortlisted bidders as part of the bid process.
