1. INTRODUCTION

1.1 Matthew Goniwe School of Leadership and Governance (MGSLG) is an agency of the Gauteng Department of Education (GDE). It was established in 2003 to serve as the capacity-building arm of the GDE and to provide empirical and research-based quality intervention programs for School Governing Bodies (SGBs) and School Management Teams (SMTs). It has since expanded its scope to include District Officials, educators, learners (RCL members), and parents.

1.2 Background – Statement of Intent

The Transformation Directorate in the Gauteng Department of Education (GDE) is tasked with creating opportunities for reasonable accommodation of staff members with comorbidities and special needs. One group of teachers that have been identified is the visually impaired with regards to the use of digital technologies. Visually impaired teachers have been appointed in main stream and special schools across Gauteng Province. Visually impaired teachers are allocated teacher assistants who help them with their special needs in order to effectively prepare and teach their respective subjects. The emergence and use of digital technologies provides an opportunity for visually impaired teachers to leverage on the affordances provided by different technologies to deliver the curriculum. The knowledge and skills of visually impaired teachers are also not the same.

2. PURPOSE

The purpose is to Identity a relevant service provider to capacitate visually impaired teachers in main stream schooling system on the use of digital technologies and use of Microsoft accessibility tools to improve curriculum delivery. This is a one year contract beginning on the 1st July 2021-30 June 2022.

3. OBJECTIVES

The objectives of the project is to:

- 3.1. Acquire the services of a credible service provider to deliver training on behalf MGSLG to visually impaired teachers in the Province.
- 3.2. Administer needs analysis and identify critical developmental needs of the targeted educators.
- 3.3. Design an appropriate needs driven program for visually impaired educators
- 3.4. Develop online and offline (audio) training materials as training support materials for visually impaired educators using the assistive technology.
- 3.5. Work with MGSLG to ensure that the programme is endorsed through SACE upon completion of the developed materials based on individual needs identified
- 3.6. Provide specialist training and facilitation support to 100 visually impaired educators on the use of Microsoft Accessibility Tools.

4. SCOPE OF SERVICES

The scope of the services shall include:

- 4.1 Conducting comprehensive needs analysis to identify critical developmental needs
- 4.2 Design an appropriate learning trajectory and program to capacitate visually impaired teachers





- 4.3 Develop appropriate learning materials using assistive technology (braille and audio) for training and supporting visually impaired teachers
- 4.4 Complete and submit all relevant documents to MGSLG for SACE endorsement of the training programme
- 4.5 Provide training and in school support to severely, moderate and mild visually impaired teachers and teacher assistants identified by the Transformation Directorate from GDE.
- 4.6 Develop and submit case study training reports quarterly
- 4.7 Use data management tools to monitor teacher progress and provide Quarterly reports thereto
- 4.8 Develop a monitoring and evaluation plan for the training program
- 4.9 Design a Skills transfer plan to train MGSLG staff on the development, design and training of visually impaired educators

5. METHODOLOGY

- a) Submit a clear proposal on the methods and timeline for the intervention.
- b) Conduct a Needs analysis to identify critical developmental needs
- c) Design a program based on needs identified
- d) Develop training and support materials
- e) Support and training should be blended
- f) Develop a Skills transfer training plan
- g) The appointed Service Provider should submit an end to end program implementation plan

5.1 PRE-QUALIFICATION COMPETENCIES & EXPERTISE REQUIREMENTS

The selection criteria to assess the technical capacity of the consultant/service provider includes the following:

- 5.1.1. A Project Leader should hold at least an advanced university degree (Masters or Higher) in Education, Social Science or any other subject relevant to education.
- 5.1.2.At least 5 years of relevant experience on special needs professional development in ICT.
- 5.1.3. The Qualified bidder should have knowledge of special needs professional teacher development.
- 5.1.4. The Qualified bidder should have team members who are qualified (experience and qualifications) to provide the training Programmes they wish to provide.
- 5.1.5.The Qualified bidder should exhibit the first-hand experience of working on training projects in collaboration with the education sector, other organizations and providers.
- 5.1.6.The Qualified bidder should demonstrate how they will incorporate 21st-century skills for teachers in their Programmes which include the integration of ICTs in the classroom.
- 5.1.7. Effective time management and organizational skills to ensure qualitative outputs under strict deadlines.

6. OUTPUTS AND DELIVERABLES

The consultancy will produce the following significant outputs:

- a) Inception report detailing methodology and work plan.
- b) Develop a training and support schedule based on allocated work and envisaged dates, where possible.
- c) Present a training Programme that uses a blended learning approach.
- d) Develop/Refine appropriate training materials for the identified training workshops.
- e) Monitor attendance of workshops and submit attendance registers on time
- f) Conduct formative assessment during training (depending on area trained)
- g) Conduct summative evaluation at the end of training (including practical exercises) and provide MGSLG with a comprehensive Pre and Post training report





- Avail formative and summative assessment reports (if Portfolio of evidence (PoE) is not completed) Offer
 Portfolio of evidence (PoE) support depending on area trained
- i) Submit monthly training reports with statistics and proof of training where applicable
- j) Attend meetings between GDE and MGSLG, if requested
- k) Submit a Final Project Close-Out Report

7. EVALUATION PROCESS

The Evaluation Process comprises the following stages:

7.1 Pre-evaluation stage/ mandatory documents

• During this phase bid documents will be reviewed to determine compliance with tax matters and whether original and valid tax clearance certificates have been submitted with the bid documents at closing date and time of bid.

Bidders must attach the following mandatory returnable documents in order to be considered for this bid:

- Original and valid tax clearance or Printed copy tax clearance certificate accompanied by a pin for further verification.
- Certified ID(s) copies of company director(s)
- Certified Proof of company registration
- Company municipal rates, electricity or water account not older than 3 Months, proof of Residential lease or rental or sworn affidavit if the business operates at a place of residence.
- Completed and signed Standard Bidding Document (SDB) attached in the tender document.
- Proof of registration on National Treasury Central Supplier database.
- Proof of company banking details
- Company profile with a minimum of 5 years' experience in working in the relevant field.
- Proof of company banking details e.g. bank letter with bank stamp, Company bank statement, code rating letter from the bank or any physical proof from the bank, the evidence must not be older than three months.

Failure to submit all of the above mentioned document will result to the disqualification of the bid.

7.2 Stage 1: Technical/Functionality Evaluation

- a) Bids will be evaluated strictly according to the bid evaluation criteria stipulated in this section of the Terms of Reference (ToR). During this stage bidders' responses will be evaluated for functionality based on achieving a minimum score of seventy five percent (75%). Bidders who obtain less than 75% in the functionality points will be regarded as non-responsive and will be eliminated from the evaluation process.
- b) Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated in this document. The panel responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.
- c) Bidders will not rate themselves, but need to ensure that all information is supplied as required. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify all documents





submitted by the bidders.

d) The panel members will individually evaluate the responses received against the following criteria as set out below:

- e) Each panel member will rate each individual criterion as per the above point allocation scales:
- **f)** The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- **g)** This score will be converted to a percentage and **only** bidders that have met or exceeded the minimum threshold of 75% for functionality will be evaluated and scored in terms of pricing and socio-economic goals as indicated hereunder.

Any proposal not meeting a minimum score of 75 percent technical proposal will be regarded as non-responsive and it will not be evaluated further.

8. STAGE 2: PRICE/FINANCIAL EVALUATION

Price, inclusive of VAT, will be evaluated as indicated below.

- a) In terms of regulation 5 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be evaluated by MGSLG on the 80/20 preference point for Broad-Based Black Economic Empowerment in terms of which points are awarded to bidders on the basis of:
 - The bid price (maximum 80 points)





- Broad-Based Black Economic Empowerment as well as specific goals (Maximum 20 points)
- **b)** The following formula will be used to calculate the points for price in respect of bidders with a Rand value below R50, 000,000.00:

Where

Ps = Points scored for comparative price of bid under consideration

Pt = Comparative price of bid under consideration, inclusive of VAT Pmin=Comparative price of lowest acceptable bid, inclusive of VAT

A maximum of 20 points may be awarded to a bidder for being a Broad-Based Economic Empowerment and/or subcontracting with a Broad-Based Black Economic Empowerment entity stipulated in the Preferential Procurement regulations. For this bid the maximum number of Broad-Based Black Economic Empowerment Status points that could be allocated to a bidder is indicated in the following section.

c) MGSLG reserves the right to arrange contracts with more than one contractor.

9. B-BBEE POINTS

The Preferential Procurement Policy Framework Act 2000 (PPPFA) Regulations were gazetted on 8 June 2011 (No. 34350) and effective from 7 December 2011. These regulations require bidders to submit valid original or certified copies of their B-BBEE Status Level Certificates from a SANAS accredited verification agency and accredited auditing firm. The 80/20 preference points systems will be applied since the bid is estimated to be above R1 Million in accordance with the formula and applicable points provided for in the respective status level contributor tables in the Regulations.

Failure to capture the required status level and to submit the certified or original B-BBEE status level certificates no points will be allocated to the service providers.

- **a.** The points scored by a bidder in respect of the points indicated above will be added to the points scored for price.
- **b.** Bidders are requested to complete the various preference claim forms in order to claim preference points.
- **c.** Only a bidder who has completed and signed the declaration part of the preference claim form will be considered for B-BBEE Status.
- **d.** Supply Chain Management may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regards to B-BBEE Status.
- e. Points scored will be rounded off to the nearest 2 decimals.
- **f.** In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for B-BBEE Status. Should two or more bids be equal in all respects, the award shall be awarded to the bidder who scored a highest functionality points, should two or more bids be equal after this, the award shall be decided by drawing of lots..
- **g.** A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.
- h. MGSLG reserves a right to withdraw, cancel or not to award this tender.

Failure to submit all of the above mentioned documents will result to the disqualification of the bid.

10. COMMUNICATION

Supply Chain Management (SCM) Unit will communicate with bidders for, among others, where bid clarity is sought, to obtain information or to extend the validity period. Any communication either by facsimile, letter or electronic mail or any other form of correspondence to any official or representative of MGSLG in respect of this bid between the closing date and the award of the bid by the bidder is prohibited.

11. PROHIBITION OF RESTRICTIVE PRACTICES

- **a.** In terms of section 4(1) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is (are) or a contractor(s) was/were involved in:
 - Directly or indirectly fixing a purchase or selling price or any other trading condition
 - Dividing markets by allocating customers, suppliers, territories or specific types of goods or services; or
 - Collusive bidding.
- b. If a bidder(s) or contractor(s), in the judgement of the purchaser, has/have engaged in any of the restrictive practices referred to above, the purchaser may, without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered or terminate the contract in whole or in part and refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

12. FRONTING

- **a.** MGSLG, in compliance with regulations, supports the spirit of Broad Based Black Economic Empowerment and recognises that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the MGSLG condemns any form of fronting.
- **b.** MGSLG, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine that accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry (DTI), be established during such enquiry/investigation, the onus will





be on the bidder/contractor to prove that fronting does not exist. Failure to do so within 14 days from date of notification may invalidate the bid/contract and may also result in restriction of the bidder/contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies MGSLG may have against the bidder/contractor concerned.

c. The awarded bidder cannot sub-contract more than 25% of the total project value to the company that is non-compliance with BBBEE companies.
